Child Protection Authority should mediate in child abduction incident by MP !!

General Secretary of the UNP

Tissa Attanayake has made a written request from Dr. Jagath Wallawatta, Chairman of Child Protection Authority to mediate immediately regarding the incident where a Member of Parliament has abducted a child from Yakkala, Gampaha area and thereby fulfill the obligation of the authority towards the children of this country. In his letter to Dr. Jagath Wellawatta Mr. Attanayake states “The media has reported that a Member of Parliament had broken into a house at Yakkala in Gampaha District and abducted a child of 12 years. Newspapers of 31st March reported this incident and there was an editorial published regarding this incident.

A Member of Parliament from Gampaha District has been involved in this incident. It is a very sad state of affairs if children have to be abducted for the petit interests of politicians. This is an incident which blatantly violates the International Charter of Rights for children for which our country is a signatory. Your ‘Authority’ too has a responsibility of mediating in such matters. The police investigations that are carried out regarding this incident are slow as usual and perpetrators would never be caught. Hence, I would kindly request you to mediate in this incident and fulfill your obligation towards the children of this country.
